

NOTICE OF PUBLIC HEARING TO ADOPT REGULATIONS

NOTICE IS HEREBY GIVEN that a formal hearing will be held to adopt amendments to Chapter 634 of the Nevada Administrative Code (NAC). These proposed amendments are scheduled to be heard by the Chiropractic Physicians= Board of Nevada at a hearing on July 11, 2008.

The proposed amendments will define when a license to practice chiropractic is in good standing; revise provisions governing a mobile chiropractic office; revise provisions governing petitions to the Chiropractic Physicians= Board of Nevada for declaratory orders and advisory opinions; remove references to a chiropractor=s assistant for massage; increase various fees charged by the Board; revise provisions governing the certification of a chiropractor=s assistant trainee; revise provisions governing the written disclosures required of chiropractors who do not maintain professional liability insurance; and provide other matters properly relating thereto.

The proposed amendments are attached.
